AGREEMENT OF COOPERATION
between
LUBLIN UNIVERSITY OF TECHNOLOGY
and
DJILLALI LIABES UNIVERSITY

In order to develop and diversify their fields of education and research, the representatives of the Lublin University of Technology, POLAND and the Djillali Liabes University of Sidi Bel-Abbès, ALGERIA, hereby agree to sign this framework agreement. Both parties affirm and sustain the importance of international cooperation in higher education and scientific activity.

The Lublin University of Technology and the Djillali Liabes University of Sidi Bel-Abbès agree to work together in order to improve academic research and education, and to develop the cooperation between the two Universities in various academic and research activities. The following general principles are agreed upon:

1. Both parties pledge themselves to cooperate in a spirit of understanding, to deepen friendly relationship and ties of mutual benefit and carry out joint academic activities, such as:
 - a. joint research projects, academic seminars and guest lectures;
 - b. staff and student mobility;
 - c. the Universities agrees to apply for funding through different exchange programs and mainly through EU Erasmus+, Horizon Europe, etc;
 - d. participation in double coordinated PhD programs and academic juries for PhD and Master programs;
 - e. exchange of academic/teaching materials, research reports, publications etc.;
 - f. additional activities which might be separately agreed.
2. Both parties will make every effort towards the development and implementation of research projects, which are of mutual interest. In the field of research the Universities agree to apply for funding through different research programs and mainly through EU Research Frameworks, etc. The Universities will organize joint scientific workshops, seminars and will encourage the participation of their staff in scientific events organized by the partner University.
3. The detailed content of above activities will be decided by mutual agreement every year. In order to finance the activities, both parties should consider all possible sources in their own countries.

4. Ownership of intellectual property resulting from the joint activities will be shared by the parties proportionally to their involvement.
5. The content of the statement can be modified by mutual agreement at any time.
6. The agreement of cooperation is valid for five years from the date of signing and may be extended by mutual consent after the expiry date. The agreement can be terminated at any time by mutual written decision.
7. This agreement is written in both English and Polish languages. Both versions have the same effect. In case of any discrepancies between the English and the Polish versions of the agreement, the English version shall prevail.
